A Brief History

- 1960s Community Shares
 - "Alternative funds" or "social action funds" formed to raise funds for nonprofit organizations that did not fit the Unity Way model
- CS affiliates raise fund through workplace giving
- In 1992, 13 diverse, social action non-profit organizations in Iowa that were unable to join Unity Way, partnered to establish Iowa Shares

Community Shares and its affiliates focused on special philanthropic interests

- Race, ethnicity
- Animal welfare
- Women's rights
- Sustainable agriculture
- The environment
- Community impact issues

What is lowa Shares (IS)?

A federation of Iowa charities allow donations through workplace contributions

501(c)3 non-profit organization, contributions are tax deductible

IS raised funds through direct donations and workplace giving since 1992

Member organizations benefit lowa communities through education, advocacy and direct services

A member of Community Shares USA which is a collaboration of organizations committed to achieving fairness and opportunity for all.

What Sets Iowa Shares Apart?

CHOICE

- Donors may select specific IS members organization
- All designated donations are honored, including those to non-IS members

FAIRNESS

 Donations that are not designated to specific organization are divided among all IS full-member organizations

EFFECTIVENESS

 Low administrative cost, majority of the donation goes to the chosen charities

LOCAL CONTROL

 IS Board is made of one representative from each full-member organization
